

General Rules (Applicable to all events)

1. The participation is open to CA Students of Udaipur Branch who satisfy at least one of the following conditions:
 - Registered under New Foundation Scheme
 - He/She has passed CPT examination/ Foundation Examination in 2017 or 2018
 - He/She is presently undergoing articleship training / has completed articleship training during 2018.
 - He/She has appeared for CA-IPCC/PCC/Final examinations in 2018.
- ❖ However, a student who has passed CA Final examination and has also completed his/her articleship is not eligible to participate.
2. A student may take part in any Five (5 in No.) events of his/her choice, including Solo and Team events.
3. Since the time allotted to each event is limited, the organizers may hold pre-selection round before the actual event. All the participants are required to participate **compulsorily** in the pre-selections so as to get selected further to perform in the final rounds on 10-11th January 2019.
4. No change in the name of participants will be allowed after submitting the forms.
5. The organizers may disqualify any participant/team on account of misbehavior/indiscipline/indecency and the decision of the organizers shall be final and binding to all.
6. In case adequate candidates are not available in any event, the event may be cancelled at the discretion of the organizing committee.
7. The Event specific rules are given in the following pages. The interested persons may contact the Event Coordinator for any clarification.

Specific rules applicable to Solo Song

1. It is an individual event.
2. The participant will be allowed a maximum of **three** minutes to perform.
3. The participant is free to choose any song (Hindi performance).
4. Repeat song will not be allowed and the song selection will be allowed on first come first serve basis.
5. A pre-selection round may be organized prior to the actual event to select the participant for final performance in the competition. The selection for final event will be done by the penal of expert & decision of them would be final.
6. The organizers will arrange for orchestra practice for the participant selected for performing in the final round. However, if due practice cannot be arranged, then the participants will have to practice on own.
7. A panel of judges will judge the performances.
8. In case of any dispute, decision of the organizers of the event shall be final and conclusive.
9. Selections date and time will be informed to participants.

Specific rules applicable to Ad-Mad Show:

1. Students will be provided instant product for which they will be given 90 minutes for preparation.
2. Students are required to:
 - a. Give a creative name to product.
 - b. Provide Punch line for the product.
 - c. Prepare a small advt. to present their product.
 - d. Prepare a jingle for the product.
 - e. Prepare a poster in regards to their product and details of product.
3. Students will be given Time for presenting their product max. **Three** minutes.
4. No. of candidates in a team is min.-2 (Two) and max.-5 (Five).

6. If no. of teams are more than required a pre-selection will be made by organizing committee.

Specific Rules for Flameless Cooking:

1. Sixty minutes Time will be given to each participant (Time can be appropriately reduced)
2. Not more than two items must be prepared.
3. All the cuttings, dressing, preparing etc. should be done in that given time including decoration of the dish.
4. No processed /precooked meat/vegetables is allowed.
5. No processed juice can be used.
6. Usage of mobile phones or any external communication will not be entertained
7. Only participants will be allowed inside the venue of the competition.

8. Participants are required to bring their own cutlery and utensils.
9. All the material required for cooking has to be brought by participant.
10. Only eating items can be used in decoration and at max Toothpick can be allowed with strict instruction of no other pins to be used.
11. Incomplete dish may result into disqualification subject to the decision of Judges/Committee.
12. No refrigeration facility will be provided. Participants have to arrange on their own for the same.
13. Participant coming late will not be allowed any extra time to compete.
14. In case of any dispute organising committee decision is final.
15. Organising Committee deserves the right to amend change any rules of this completion.
16. Participation will be done only individual basis.

Quiz Competition

1. Maximum participants will be 48 in buzzer quiz.
2. The organizers may hold pre-selection round before two –three days of the actual event . Participants are required to participate compulsorily in the pre-selection written exam to get selected further for the final rounds on 10th January 2019.
3. No.of candidates in a team will be 4 (Four) and teams will be formed by the Organisers.
4. Number of rounds and Quiz structure will be decided by the organisers .
5. In case of a tie-up a five question round will be held.
6. Question will be related to CA Inter syllabus , general knowledge, mental ability riddles

Specific rules applicable to Fans of Bollywood:

1. Each Team will have Separate codes.
2. Maximum Team members in a team are restricted to four.
3. A pre-selection round may be organized prior to the actual event to select the participants for final performance in the competition.
4. A panel of judges will judge the answers (including the buzzer round) and decide Winners.
5. In case of any dispute, decision of the organizers of the event shall be final and conclusive.

Specific rules applicable for Mr. & Miss Cacophony 2019:

1. Each Participant will have Individual codes.
2. Their will be following rounds:
First round: will be of Dress theme
Second round: will be of Dress theme along with a prop.
Third round : Special theme round
 The prop will be provided by organizing committee. The round will judged on basis of cat walk & posture, dance and greeting the audience and use of prop. before going back with cat walk. (These may be changed at the discretion of the Organizing Committee & in case the same are changed, the same shall be informed separately).
3. In case the dress up is not up to standard or does not appear to be sober, the candidate may be disqualified at the discretion of the organizing Committee.
4. A pre-selection round may be organized prior to the actual event to select the participants for final performance in the competition.
5. The organizers will arrange for music.
6. A panel of judges will judge the performances and decide Winner Team, Mr. Cacophony & Miss CAcophony.
7. In case of any dispute, decision of the organizers of the event shall be final and conclusive.
8. In case the dresses provided by sponsors are damaged or torn the student will be required to pay for the same.

Specific rules applicable to Group/Solo Dance:

1. Each Participant will have Individual codes.
2. Participants are required to bring their own CDs or PDs
3. The CDs or PDs are required to be submitted 4 days before the event. Last moment submitted CD's or PDs will not be accepted & Participants will be disqualified. Also, Last moment change of track is not allowed.
4. Participants are free to choose theme or Songs.
5. In case of solo dance, one prop is compulsory to be used which should not be dangerous or cause harm. Participants may use prop in group dance, if required.
6. In case of group dance, there should be any message convey from the dance.
7. Maximum time limit for solo dance is 3 minutes and for group dance is 5 minutes.
8. Dress/costume and other accessories has to be arrange by the participants at their end.
9. Participants can use PPT presentation for solo/group dance which will be display at the stage during the performance if possible.
10. In case of any dispute, the decision of the organizing Committee will be final
11. In case the dress up is not up to standard or does not appear to be sober, the candidate may be disqualified at the discretion of the organizing Committee.
12. A pre-selection round may be organized prior to the actual event to select the participants for final performance in the competition.

Specific rules applicable to Best out of Waste

Reduce, Recycle, Reuse can be explained to the people by conducting activities like Best out of Waste which gives scope for creative thinking. Eco clubs in environment are the means by which students can be empowered to participate and take up meaningful environment activities and projects. Preparation of eco-friendly product out of waste material forms an important part of eco club. Creating something useful out of waste things... a concept which has global significance and gives a new idea to implement and recycle products which were otherwise redundant. As it enable us to make the useless things more useful.

1. Participant cannot participate in group/ team only a single student can participate.
2. Only waste material can be used for the purpose of this competition. That is minimum 95% of all the things should be a waste material. If it is not so Judges reserve the right to disqualify the art work.
3. Other than waste material, glue fevicol other adhesives, pins, colors, cells can be used to enhance and give finishing to art work.
4. All the required material has to be brought by the participants themselves, nothing will be supplied by the Institute/Organisers.
5. Participants are not allowed to bring any structure partly or fully made; all the art work are required to be prepared only during the allotted time.
6. A panel of judged will judge the work and decide the winner.
7. In case of any dispute decision of organisers will be final;

Specific rules applicable to Stand up Comedy Show

1. It is an individual competition.
2. Limited entries based on first come first serve basis.
3. The participant will be allowed a maximum of four minutes to perform
4. Participants will be judged on the basis of content, fluency, spontaneity, presentation, sense of humor & overall performance.
5. No participant can point out any individual or religion in any way, and any dual meaning obscene content is strictly not allowed.
6. Negative marking for exceeding time limit.
7. Decision of the judges will be final and binding.
8. In case of any dispute, decision of the organizers of the event shall be final and conclusive.

Specific rules applicable One Minute Show

1. Total No. of game round will be Four (4)
2. In each game top performing players will be selected based on total no of participants.
3. Each Player should play the game individually without help of any other person/player.
4. In case of tie/draw between players, tie breaker game will be played and only one winner will be announced.
5. In case of any dispute decision of the judges will be final.

Specific rules applicable to Special Talent Hunt

1. It will be a single round game.
2. Every Participant has to perform on stage.
3. Mike will be provided by the organizers and anything else viz table, or any instrument or any prop which he wants to bring for his performance has to be arranged by the participant only.
4. In this Competition Participants have to show their hidden talent other than Singing, Dancing, Poetry & Comedy as in these competition he/ she can participate separately.
5. Performance should not be vulgar or inappropriate. In such cases he will be disqualified immediately by the judges. No participant can point out any individual or religion in any way, and any dual meaning obscene content is strictly not allowed

Specific rules applicable to Ultimate Photo

1. Participants may be given a theme on which they have to click a photo.
2. Soft copies of the photograph will be allowed.
3. Photos may be on camera or Smart phones.
4. Best Photo on the basis of its beautifulness and altogether different and amazing from others will be chosen.
5. Decision of the Judges will be final.
